NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE TO PROVIDE
ALTERNATIVE ACCESS VENDOR SERVICES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Southern Light, LLC (Southern Light) has applied for a certificate to provide Alternative Access Vendor (AAV) services pursuant to Section 364.337, Florida Statutes. Upon review of its application, it appears that Southern Light has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant Certificate No. 7945 to Southern Light.

If this Order becomes final and effective, it shall serve as Southern Light's certificate. Southern Light should, therefore, retain this Order as proof of certification. The Commission is

vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

AAV providers are subject to Chapter 25-24, Florida Administrative Code, Part XIV, Rules Governing Alternative Access Vendor services, as well as the terms and conditions of Order No. 24877, issued August 2, 1991. AAV providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to Southern Light for payment in January. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve Southern Light from its obligation to pay RAFs.

Based on the foregoing, it

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. 7945 to Southern Light, LLC, which shall authorize it to provide Alternative Access Vendor services, subject to the terms and conditions specified in the body of this Order. It is further


ORDERED that this Order shall serve as Southern Light, LLC's certificate and should be retained by Southern Light, LLC as proof of certification. It is further
